ORDINANCE NO. 22-46

AN ORDINANCE ADOPTING THE 2023 ANNUAL MEETING SCHEDULE FOR MEETINGS OF THE WEST JORDAN CITY COUNCIL, THE BOARD OF TRUSTEES OF THE MUNICIPAL BUILDING AUTHORITY OF THE CITY OF WEST JORDAN, THE BOARD OF TRUSTEES OF THE REDEVELOPMENT AGENCY OF

THE CITY OF WEST JORDAN, AND THE BOARD OF TRUSTEES OF THE WEST JORDAN FAIRWAY ESTATES SPECIAL SERVICE RECREATION DISTRICT

WHEREAS, per Utah Code Annotated 10-3-502 (1), the City Council shall by ordinance prescribe the time and place for holding its regular meeting and the Council shall hold a regular meeting at least once each month; and

WHEREAS, per Utah Code Annotated 52-4-202 the Utah State Legislature has further required public bodies which hold regular meetings scheduled in advance over the course of a year to give public notice of the annual meeting schedule, and to include the date, time, and place of such meetings; and

WHEREAS, per West Jordan City Code 1-13-1 the City Council shall also set the meeting schedules of other City Council bodies that hold regular meetings over the course of a year; and

WHEREAS, the City Council has deemed it appropriate to establish an annual meeting schedule for the year 2023 for meetings of the City Council and other City Council Boards and Committees,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

Section 1. <u>Adoption of Annual Meeting Schedules</u>. The City Council hereby adopts the 2023 Annual Meeting Schedules as listed below and attached, for the City Council, and other City Council Boards, and Committees.

- a. <u>Location of Meetings</u>: During the remodeling of City Hall, City Council meetings will be held at Thomas M. Rees Justice Center, Community Room, 8040 South Redwood Road, West Jordan, UT 84088. Once the remodeling of City Hall is complete, receives occupancy and ready for regular operations, meetings will then be held at West Jordan City Hall, 8000 S Redwood Road, in the Council Chambers on the 3rd Floor, West Jordan, UT 84088 which will be noted on all posted agendas. From time to time, meetings may be held at other locations as necessary and as lawfully designated by the City Council, or other City Council Boards, and Committees. The time and location of all meetings will be noted at the top of the posted agenda for that meeting.
- b. <u>Renoticing</u>: The City Council directs and authorizes the Council Office Director or designee to renotice the 2023 Annual Meeting Schedule when the council determines to begin meeting in the Council Chambers located on the 3rd Floor of West Jordan City Hall.

Section 2. <u>Publication of Meeting Schedules</u>. The City Recorder or designee is directed and authorized to publish a copy of the attached Annual Meeting Schedules (i) at the principal office of the

public body; (ii) on the Utah Public Notice website; (iii) on the West Jordan City website; and (iv) to a newspaper or local media correspondent.

Section 3. <u>Effective Date</u>. This Ordinance shall become effective immediately upon posting or publication as provided by law if any of the following occur:

- a. The Mayor signs the ordinance as provided by law;
- b. The Mayor vetoes the ordinance as provided by law and at the City Council's next meeting following the Mayor's veto the City Council passes the ordinance over the Mayor's veto by an affirmative vote of at least five (5) City Council members; or
- c. The Mayor fails to sign the ordinance within fifteen (15) days after the City Council presents the ordinance to the Mayor.
