PUBLIC NOTICE is hereby given that the Annual Meeting Schedule for the West Jordan City Council for 2022 shall be as follows:

COUNCIL MEETINGS are typically scheduled for the second and fourth Wednesday of each month. Work Sessions will begin at 5:30 pm in the Community Room, 1<sup>st</sup> Floor, with the Regular meeting beginning at 7:00 pm, in the City Council Chambers, West Jordan City Hall, 8000 South Redwood Road, 3<sup>rd</sup> Floor, West Jordan, Utah. Once the remodeling of City Hall begins, meetings will then be held at the Justice Center, 8040 S Redwood Road, in the Community Room, West Jordan, UT 84088 which will be noted on all posted agendas. The time and location of all meetings will be noted at the top of the posted agenda for that meeting.

All meetings of the City Council are open to the public unless closed pursuant to the applicable provisions of Utah’s Open and Public Meetings Act. As a general rule, a written agenda of each open meeting will be posted in the lobby of City Hall by 5:00 pm on the Friday preceding such meeting, but no later than 24 hours before the meeting (except in the event of an emergency). The agenda is also made available on the City website and the Utah Public Notice website. Additionally, notification of the posted agenda shall be provided to at least one newspaper of general circulation within the City or to a local media correspondent.

At the discretion of the City Council, they may by motion, cancel, change the time of any scheduled meeting, and may schedule additional meetings as circumstances require. Appropriate notice will be given for such meetings.
