**ORDINANCE NO. 22-27**

**AN ORDINANCE AMENDING THE CITY OF WEST JORDAN  
CONSOLIDATED FEE SCHEDULE**

WHEREAS, the City Council desires to update certain fees shown in the West Jordan Consolidated Fee Schedule to better recover the cost of providing the related services; and

WHEREAS, the City Council hereby finds this action in the best interest of the City.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

*Section 1.* The City Council hereby amends the Consolidated Fee Schedule for West Jordan City as shown in Exhibit A attached hereto and incorporated herein by reference.

*Section 2.* If any provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, the remainder shall not be affected thereby.

*Section 3.* This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.

ADOPTED by the City Council of West Jordan, Utah this 10<sup>th</sup> day of August, 2022.
