ORDINANCE NO. 22-44

AN ORDINANCE RENAMING NEW BINGHAM HIGHWAY FROM 7800 SOUTH TO 5600 WEST TO COPPER HILLS PARKWAY

WHEREAS, the City has received a request from Copper Hills Highschool Community Council to rename “New Bingham Highway” between 7800 South and 5600 West to “Copper Hills Parkway”; and

WHEREAS, Copper Hills Highschool feels replacing the name of a rival school (Bingham) to Copper Hills will increase community pride; and

WHEREAS, the City Council held a public hearing on October 12, 2022 regarding the proposed street rename; and

WHEREAS, City Code 7-5-1 vest the Council with authority to approve requests to change city street names of its own accord and finds it to be in the best interest of the welfare of the residents of the City to adopt the proposed name change.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST JORDAN, UTAH AS FOLLOWS:

Section 1. Street Name Change – Council authorizes the renaming of New Bingham Highway between 7800 South and 5600 West to “Copper Hills Parkway” as proposed on the map provided in Attachment 1.

Section 2. Severability. If any provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, the remainder shall not be affected thereby.

Section 3. Effective Date. This Ordinance shall become effective immediately upon posting or publication as provided by law and upon (i) the Mayor signing the Ordinance, (ii) the City Council duly overriding the veto of the Mayor as provided by law, or (iii) the Mayor failing to sign or veto the Ordinance within fifteen (15) days after the City Council presents the Ordinance to the Mayor.
