Pre-application meetings take place only on Monday between the hours of 2pm and 4pm. To schedule a pre-application meeting; submit the following documents, along with this application form by 3pm Tuesday one week prior. You will be notified by the assigned project manager of the time when your meeting is scheduled.

- Submit the pre-application form and the required documents to WJPlanning@westjordan.utah.gov. PDF files are required for all submittals and plans.
- After submittal you will receive an email verification that the form and documents have been received. Incomplete submittals will not be accepted.
