HAVE TIME FOR PUBLIC COMMENT. WITH PUBLIC COMMENTS, WE ARE FREE TO COME UP AFTER I CALL ON A FEW PEOPLE THAT HAVE ALREADY PUT THEIR NAME IN, AND Y'ALL HAVE A CHANCE TO SPEAK FOR THREE MINUTES. THE COUNCIL TYPICALLY DOES NOT RESPOND, SO IF YOU DO NEED A RESPONSE, WE WOULD ASK THAT YOU TALK TO OUR COUNCIL OFFICE PEOPLE OVER HERE AND THEY CAN GET YOUR NAME AND YOUR NUMBER AND MAKE SURE THAT WE CAN GET BACK WITH YOU. SO THE FIRST NAME I HAVE UP TONIGHT, AND I HOPE I SAY THIS RIGHT, IS CHANEL CHANEL HILL. SO IF YOU WANT TO COME FORWARD AND YOU HAVE THREE MINUTES AT THE AT THE LECTERN. ONE. I AM HERE TODAY BECAUSE OUR CITIES NEED TO TAKE A STAND ON CORRUPTION, ABUSE AND THE EXPLOITATION OF RELIGIOUS PROTECTIONS. LAST WEEK, MAYOR KRISTI ROBERSON OF TAYLORSVILLE TOLD ME MY CONCERNS ABOUT RELIGIOUS ORGANIZATIONS MISUSING THEIR 500 AND 1C3 STATUS TO COMMIT CRIMES AGAINST CHILDREN WERE MATTERS FOR THE LEGISLATOR.

BUT CHANGE DOESN'T START JUST AT A STATE LEVEL. IT STARTS WITHIN OUR CITIES WITH LOCAL POLICIES AND ORDINANCES THAT ENSURE ACCOUNTABILITY. RIGHT NOW, WE ARE SEEING YET ANOTHER KINGSTON CASE, ANOTHER EXAMPLE OF RELIGIOUS GROUP EXPLOITING CHILDREN, MARRYING YOUNG AND HIDING CRIMES. ORGANIZATIONS HAVE BEEN ABLE TO PREVENT LAW ENFORCEMENT FROM PROPERLY INVESTIGATING AND PROSECUTING. IF I GO TO THE LEGISLATURE AND THEY ASK ME WHICH CITIES HAVE HAD WHICH CITIES STAND BEHIND ME, I HAVE TO SAY NONE. I WILL NOT BE TAKEN SERIOUSLY. WE NEED LOCAL OFFICIALS TO TAKE THE ISSUE SERIOUSLY AS WE DO. WE ALSO NEED TO STAND AGAINST THE CORRUPTION OF ATTORNEY GENERAL REYES, WHO SUPPORTED TIM BALLARD DESPITE SERIOUS ALLEGATIONS AGAINST HIM. BALLARD HAS BEEN ALLOWED BY THE DEPARTMENT OF CORPORATIONS TO YET START ANOTHER FOUNDATION UNDER THE GUISE OF FIGHTING TRAFFICKING. HOW DOES SOMEONE FACING SUCH
