### 3. SPECIAL RECOGNITION

# a. City Council Reports

Council Member Green expressed excitement for the 2025-26 Youth Council, attending the Transjordan ribbon cutting, and gave an update from the Salt Lake Valley Mosquito Abatement District regarding their efforts to alleviate concerns with West Nile Virus and noted that based on the certified tax rate their proposal dropped to \$0.77/household.

Council Member Jacob sent a report from Jordan Valley Water to the Council by email and expressed a desire to stay on the board in 2026.

Council Member Bedore encouraged residents to reach out to the council noting the lack of attendance at recent town halls scheduled for that purpose. He looked forward to attending "Out of Darkness" a suicide walk on Saturday and encouraged anyone in need to call "988" for help.

Council Member Shelton attended an event to honor three young men who saved pets from a house fire, the recent First Friday concert, the Push-In Ceremony at the West Jordan Fire Department, a West Jordan Police Department Memorial dedication event, and congratulated the K-9 Unit for taking first at a recent competition.

#### b. Council Office Report

Policy Analyst & Public Liaison Warren Hallmark reported of two inquiries for Youth Council which would fulfill the max allowed and noted their first meeting was successful and they had a great group to work with for 2025-26.

### c. Mayor's Report

Mayor Dirk Burton reported of recent events: Citizens Academy, Push In Fire Engine Ceremony, Copper Hills High School recognition of three young' heroic efforts to save pets from a house fire, First Friday record attendance (867 attendees), and K9 Officer Kilo.
