3. SPECIAL RECOGNITION

a. West Jordan Police Department Badge Pinning Ceremony
Chief Wallentine recognized recently promoted officers: Tyler Webster, Lieutenant and
Gage Hoogveldt, Sergeant along with new officers: Justice Brusatto, Otto Dubon, Jennifer
Justice, Tseitel Pacheco, and Jade Vaterlaus.

4. PUBLIC COMMENT

Hunter Jones, resident, asked Council and Police Officers to focus on aggressive driving in order to save lives.

Brinley, high school resident, expressed appreciation for the kindness of Council Members and their hard work.

5. PUBLIC HEARINGS

- a. Ordinance No. 25-50 Amending City Code Section 13-5F-2 Permitted and Conditional Uses to Allow Veterinary Services as a Permitted Use in the M-1 Zone APPROVED 7-0 Next Steps: the approved amendments to Section 13-5F-2 will be updated in City Code and Veterinary Services will be a permitted use in the M-1 Zone
- b. Ordinance No. 25-51 Petition to Rename the Cul-de-sac at 2290 West (off 7600 South) to Poison Spider Circle DENIED 6-1 (Lamb opposed)
 Rob Bennett, Ron Cossure, and Josh Standfield spoke in opposition to the petition, expressing the opinion that it did not meet the intent of the code and voiced concerns over the personal costs to change their address. Following the public hearing, the Council voted to deny the request, which passed 6-1 (Lamb opposed).

Next Steps: residents in the cul-de-sac may choose to work together for a solution including providing a new application if desired

c. Ordinance No. 25-49 Amending West Jordan City Code Section 13-5E-3 Allowing Motor Vehicle Sales as a Conditional Use in the C-M (Heavy Commercial) Zone APPROVED 7-0 Next Steps: the approved amendments to Section 13-5E-3 will be updated in City Code allowing Motor Vehicle Sales as a conditional use in the C-M Zone

6. BUSINESS ITEMS

 a. Ordinance No. 25-54 Amendment to West Jordan City Code Title 7, adding Chapter 6 (Golf Carts) APPROVED 4-3 (Lamb, Whitelock, Bedore opposed) Next Steps: the approved amendments to Title 7 will be updated in City Code and Golf Cart regulations will be added in Chapter 6.

7. REPORTS TO COUNCIL

a. City Council Reports

Council Member Green shared statistics regarding West Nile Virus concerns and encouraged preventative measures. He expressed gratitude for the opportunity to stand before the United States Supreme Court supporting Patrick Boice.

Council Member Shelton attended a Project Civility conference in Indiana and noted an opportunity for Council Members to participate in an online course to learn more about the program.

Vice Chair Bedore announced the Sugar Factory Playhouse production of the "Hasty Heart" from October 16-25, 2025, performed at the new Canyon View Credit Union Community and Arts Center.

b. Council Office Report

Council Office Director Alan Anderson shared meeting streaming analytics, noting a viewer from Denver tuned in. He expressed appreciation for the Council's support of the Youth Council and staff.

c. Mayor's Report

Mayor Burton appreciated the Council attending ULCT Annual Conference. He reported that a lighted stop sign had been installed to improve visibility at an intersection where an automobile accident had recently taken place. He announced upcoming city events: Crafts & Cravings, Meet the Candidates, Gold Star Memorial, Emergency Preparedness, and Dumpster Days.

d. City Administrator's Report

City Administrator Korban Lee noted strong presentations and participation in the Citizen Academy, announced the planting of 120 trees over the next six months, and invited Council to the upcoming Veteran's Day event. He noted recent storm water upgrades performed admirably during heavy rains, paving projects should be completed by the end of the month, and Furniture Row was set to open in early November.
