Applicant shall adhere to the following standards for temporary signs as set forth in the West Jordan Sign Ordinance Code Sections 12-3-2 and 12-3-3.

☐ **A-FRAME SIGNS** **PERMIT FEE: \$35.00**

1. Maximum Area: The sign portion of an A-frame sign shall not exceed 10 square feet with a maximum of two sign faces.
2. Maximum Height: The A-frame sign shall not exceed 4-feet in height.
3. Density: One sign per business is allowed.
4. Spacing: 75-feet from any other sign.
5. Front Setback: The A-frame sign must be within 20-feet of the primary entrance to the business.
6. Limitation on Use: In those zoning districts where A-frame signs are permitted, their use is limited to areas of high volume pedestrian traffic.
7. Display Period: Use of an A-frame sign shall be limited to normal business hours. Signs shall be stored indoors at all other times.
8. Weather Restrictions: A-frame signs shall not be used outdoors when high wind or heavy snow conditions exist.

I certify that the information on this application furnished by me is true and correct and that the applicable requirements of the City of West Jordan will be met. I understand that this application does not constitute a permit to display signage. Certification is hereby rendered that no signage will be displayed prior to gaining a temporary permit, and that all signage displayed after approval will comply with the West Jordan Municipal Code. I acknowledge that a violation of any ordinance may result in the revocation of my temporary sign permit, a citation, and/or fines.
